

TOWN OF KETCHUM
PLAN FOR EXTENSION OF SERVICES TO ANNEXED TERRITORY

DATED JANUARY 8, 2024

Pursuant to Title 11 O. S. Section 21-104 the Board of Trustees of the Town of Ketchum does hereby submit its proposed plan for extension of appropriate town services to the to the territory to be annexed.

WATER SERVICE: Municipal water service shall be provided by the Ketchum Public Works Authority. Individual service connections shall be established in accordance with the policies and conditions of the KPWA as adopted and in existence from time to time. Any consumer within the annexed territory who desires to have service furnished sooner than that otherwise available under such policies and conditions shall be permitted to pay the cost and expense of water line extension from the existing KPWA system to such consumer.

SEWER SERVICE: Sanitary sewer service to residents and occupants of the annexed territory shall be provided by the Ketchum Public Works Authority (KPWA). Individual service connections shall be established in accordance with the policies and conditions of the KPWA as adopted and in existence from time to time. Any consumer within the annexed territory who desires to have service furnished sooner than that otherwise available under such policies and conditions shall be permitted to pay the cost and expense of sewer line extension from the existing KPWA system to such consumer. All extensions of sewer service shall be subject to sewer plant capacity limits and limitations imposed by state or federal regulatory authorities.

POLICE SERVICE: Police protection services within the annexed territory shall be provided by the Town of Ketchum. Such service shall commence upon final passage and implementation of the annexation of the proposed territory. The Town of Ketchum may elect to provide such services through contracts with other law enforcement agencies.

FIRE SERVICE: Fire control and response services within the annexed territory shall be provided by the Town of Ketchum. Such service shall commence upon final passage and implementation of the annexation of the proposed territory.

SOLID WASTE SERVICE: Solid waste and trash removal service within the annexed territory shall be provided in the same manner as such service is provided to the other residents and occupants of the Town of Ketchum. Presently, such service is provided by independent contractors who contract directly with such residents or consumers.

STREET MAINTENANCE: The maintenance, repair and/or replacement of highways, streets and other public roadways within the annexed territory shall be provided by the Street Department of the Town of Ketchum except as to those highways, streets and other public roadways which are maintained by the State of Oklahoma or a County of the State of Oklahoma or for which another political entity or subdivision has primary

responsibility for maintenance, repair and/or replacement under the laws of the State of Oklahoma.

The extension of services by or on behalf of the Town of Ketchum shall, at all times, be subject to the availability of sufficient and adequate funding and capacity for the commencement and operation of such service or services without impairment of existing operations of the Town of Ketchum. Such extensions of service shall be further subject to all laws, regulations, rules, decrees and limitations imposed by county, state or federal authorities.

The Board of Trustees of the Town of Ketchum shall complete the implementation of this plan within a reasonable time to be determined at the public hearing on the annexation of the proposed territory.

A copy of this Plan shall be available for inspection by the public at the office of the Town Clerk in the Ketchum Municipal Building, 124 E Broadway Avenue, Ketchum, Oklahoma.
